17 TITLE I. GOVERNMENT DIRECTION AND SUPPORT

18 SUBTITLE A. BONUS AND SPECIAL PAY

19 Sec. 1001. Short title.

20 This subtitle may be cited as the "Bonus and Special Pay Limitation Act of 2013".

21 Sec. 1002. Bonus and special pay limitations.

22 (a) For fiscal year 2014, no funds may be used to support the categories of special awards
23 pay or bonus pay; provided, that funds may be used to pay:

- 24 (1) Retirement awards;
- 25 (2) Hiring bonuses for difficult-to-fill positions;
- 26 (3) Additional income allowances for difficult-to-fill positions;
- 27 (4) Agency awards or bonuses funded by private grants or donations;
- 28 (5) Safe driving awards;
- 29 (6) Gainsharing incentives in the Department of Public Works;
- 30 (6) Suggestion or invention awards; or

1 (7) Any other award/bonus required by an existing contract or collective
2 bargaining agreement that was entered into before the effective date of this subtitle.

3 (b) No special awards pay or bonus pay may be paid to a subordinate agency head or an
4 assistant or deputy agency head unless required by an existing contract that was entered into
5 before the effective date of this subtitle.

6 (c) Notwithstanding any other provision of law, no restrictions on the use of funds to
7 support the categories of special awards pay (comptroller subcategory 0137) or bonus pay
8 (comptroller subcategory 0138) shall apply in fiscal year 2014 to employees of the District of
9 Columbia Public Schools who are based at a local school or who provide direct services to
10 individual students.

11 **SUBTITLE B. INNOVATION FUND ESTABLISHMENT**

12 Sec. 1011. Short title.

13 This subtitle may be cited as the "Innovation Fund Establishment Act of 2013".

14 Sec. 1012. Definitions.

15 For the purposes of this subtitle, the term:

16 (1) "Fund" means the Innovation Fund established in section 1013.

17 (2) "Grant managing entity" means the Community Foundation for the National
18 Capital Region pursuant to section 1016.

19 Sec. 1013. Innovation Fund.

20 (a) There is established a Innovation Fund ("Fund") to provide sub-grants to nonprofit
21 organizations in education, job training, health, services for seniors, arts, public safety, and the
22 environment.

23 (b) The Mayor shall make a grant to a single grant managing entity of which at least 94%
24 shall be used to make sub-grants for the purpose of promoting a growing economy, educational
25 improvement, increasing sustainability, and improving the quality of life for all residents. The
26 remaining 6% shall be utilized for administrative expenses and evaluation of the Fund.

1 (c) The Fund is designed to provide sub-grants to nonprofits in education, job training,
2 health, services for seniors, arts, public safety, and the environment. The funds shall be available
3 for conveyance to a grant managing entity for the purposes identified in subsection (b) of this
4 section.

5 (d) Sub-grants shall be awarded, subject to the availability of funding, as follows:

6 (1) All sub-grants shall be awarded on a competitive basis;

7 (2) The sub-grants shall not exceed \$100,000 per year;

8 (3) Capacity building sub-grants are one-time and can be carried over for a
9 maximum of 3 years;

10 (4) Program development sub-grants are limited to a maximum of 3 years and
11 contingent on first-year grant outcomes;

12 (5) The sub-grant funds shall be used exclusively to serve District of Columbia
13 residents;

14 (6) Independent review panels shall be used as part of the sub-grant selection
15 process; and

16 (7) All sub-grants shall be subject to District transparency requirements such as
17 Freedom of Information Act requests.

18 (e) The Fund shall be administered pursuant to the requirements set forth in the Grant
19 Administration Act of 2013, passed on 2nd reading on June 18, 2013 (Enrolled version of Bill
20 20-199).

21 Sec. 1014. Required information before approval.

22 (a) To be eligible to receive a sub-grant from the grant managing entity pursuant to
23 section 1013, a sub-grantee shall submit the following required documentation to the grant
24 managing entity as well as any additional information required by the grant managing entity:

1 (1) Internal Revenue Service certification that the organization is tax-exempt
2 under section 501(c)(3) of the Internal Revenue Code of 1986, approved August 16, 1954 (68A
3 Stat. 163; 26 U.S.C. § 501(c)(3));

4 (2)(A) The organization's most recent financial audit, not more than 2 years old;
5 or

6 (B) A recent financial statement, not more than one year old, prepared by
7 a certified accountant that shows that the organization is in good financial standing and which
8 delineates its:

9 (i) Existing assets and liabilities;

10 (ii) Pending lawsuits, if any; and

11 (iii) Pending and final judgments, if any.

12 (3) Internal Revenue Service Form 990 covering the organization's most recently
13 completed fiscal year;

14 (4) A notarized statement from the sub-grantee certifying that:

15 (A) The organization is current on District and federal taxes;

16 (B) The grant managing entity is authorized to verify the organization's tax
17 status with the Office of Tax and Revenue and the Office of Tax and Revenue is authorized to
18 release this information to the grant managing entity;

19 (C) The grant managing entity shall have access to the sub-grantees
20 financial, administrative, and operational records, including specific consent for the grant
21 managing entity to access its books, accounts, records, findings, and documents related to the
22 sub-grant; and

23 (D) The sub-grantee is registered with the Department of Consumer and
24 Regulatory Affairs; and

25 (5) A comprehensive program statement that includes a detailed:

26 (A) Scope of work; and

1 (B) Budget that describes how the sub-grant funds shall be spent.

2 Sec. 1015. Reporting requirements.

3 Beginning January 2, 2015, the grant managing entity shall submit an annual report to the
4 Mayor and the Council of all District funds allocated, which includes:

5 (1) Detailed sub-grantee data;

6 (2) Performance measures and performance outcomes under each sub-grant;

7 (3) The specific services provided under each sub-grant;

8 (4) The entity providing the services, if one other than the sub-grantee;

9 (5) The time period of delivery of the services;

10 (6) The type of service provided;

11 (7) The actual amount paid for the services; and

12 (8) The amount of other expenditures under the sub-grant, if any.

13 Sec. 1016. Authorization for grant-managing entity.

14 For fiscal years 2014, 2015, and 2016, the Community Foundation for the National
15 Capital Region ("Community Foundation") is designated as the grant managing entity. The
16 Community Foundation shall be required to enter into a Memorandum of Understanding
17 ("MOU") with the District of Columbia government. The MOU shall set forth certain
18 administrative requirements for the Community Foundation to abide by when it obtains District
19 funds and awards sub-grants involving District funds, and will clarify and reaffirm the
20 Community Foundation's responsibility and obligation with respect to District funds, including
21 the monitoring of the use of District funds.

22 Sec. 1017. Limitation on duplicative projects.

23 (a) The grant managing entity shall take steps to avoid awarding sub-grants to a nonprofit
24 that has been awarded or is being awarded funds from the DC Children and Youth Investment
25 Trust Corporation ("Trust") for the same or similar program purposes for which it is applying for
26 funding from the Fund.

1 (b) Within 30 days after the effective date of the MOU, the grant managing entity shall
2 provide to the Mayor, or his or her designee, and the Council, a plan that sets forth procedures
3 for avoiding the award of duplicative funds from the Trust and the Fund.

4 **SUBTITLE C. DEPARTMENT OF GENERAL SERVICES PROTECTIVE**
5 **SERVICES DIVISION**

6 Sec. 1021. Short title.

7 This subtitle may be cited as the "Department of General Services Protective Services
8 Division Amendment Act of 2013".

9 Sec. 1022. Section 1023(6) of the Department of General Services Establishment Act of
10 2011, effective September 14, 2011 (D.C. Law 19-21; D.C. Official Code § 10-551.02(6)), is
11 amended to read as follows:

12 "(6) Protective Services Division, which shall coordinate, manage, and provide
13 security services for District government facilities through the use of special police officers and
14 security officers, as defined in D.C. Official Code § 47-2839.01, civilian employees, or
15 contractors."

16 **SUBTITLE D. CAPTIVE INSURANCE**

17 Sec. 1031. Short title.

18 This subtitle may be cited as the "Captive Insurance Amendment Act of 2013".

19 Sec. 1032. The District of Columbia Medical Liability Captive Insurance Agency
20 Establishment Act of 2008, effective July 18, 2008 (D.C. Law 17-196; D.C. Official Code
21 § 1-307.81 *et seq.*), is amended as follows:

22 (a) Section 2 (D.C. Official Code § 1-307.81) is amended as follows:

23 (1) Paragraph (2) is amended by striking the phrase "District of Columbia
24 Medical Liability Captive Insurance Agency" and inserting the phrase "Captive Insurance
25 Agency" in its place.

26 (2) A new paragraph (2A) is added to read as follows:

1 "(2A) "Act of terrorism" shall have the same meaning as provided in section
2 102(1) of the Omnibus Anti-Terrorism Act of 2002, effective October 17, 2002 (D.C. Law 14-
3 194; D.C. Official Code § 22-3152(1)).".

4 (4) A new paragraph (4A) is added to read as follows:

5 "(4A) "District real property asset" means improved real property owned by the
6 District and includes all structures of a permanent character erected on or affixed to the
7 property.".

8 (5) Paragraph (5) is amended by striking the phrase "Medical Liability Captive"
9 both places it appears and inserting the phrase "Captive" in its place.

10 (6) A new paragraph (8A) is added to read as follows:

11 "(8A) "Medical malpractice" means professional negligence by act or omission by
12 a health care provider in which the treatment provided falls below the accepted standard of
13 practice in the medical community and causes injury or death to the patient, with most cases
14 involving medical error.".

15 (7) A new paragraph (9A) is added to read as follows:

16 "(9A) "Property insurance" means an insurance policy that protects against most
17 risks to property such as earthquakes, floods, acts of terrorism, fires, boiler or machinery failures,
18 business interruptions, pollution, fidelity, builders risk, debris removal, and weather damage.".

19 (b) Section 3 (D.C. Official Code § 1-307.82) is amended to read as follows:

20 "Sec. 3. Establishment of the Captive Insurance Agency.

21 "(a) There is established, as a subordinate agency, the Captive Insurance Agency.

22 "(b) The purpose of the Agency is to:

23 "(1) Provide medical malpractice liability insurance policies for health centers,
24 including coverage for the staff, contractors, and volunteer service providers for the services
25 provided at the health centers; and

26 "(2) Provide property insurance for District real property assets.

1 "(c) The liability of the Agency for medical malpractice liability and property insurance
2 policies shall be limited to the funds in the Captive Trust Fund."

3 (c) Section 4(a) (D.C. Official Code § 1-307.83(a)) is amended follows:

4 (1) Paragraph (1) is amended to read as follows:

5 "(1) By delegation from the Mayor, to exercise procurement authority as is
6 necessary or proper to carry out the provisions and purposes of this act, including contract
7 oversight and contracting with:

8 "(A) Other insurance companies, captives, risk pools, re-insurers, and
9 other similar entities;

10 "(B) Similar captives of other states, municipalities, or counties for the
11 joint performance of common administrative functions; and

12 "(C) Persons or other entities for the performance of organizational,
13 management, or administrative functions;"

14 (2) A new paragraph (4A) is added to read as follows:

15 "(4A) ~~Obtaining~~Obtain and issue policies of property insurance, ~~for District real~~
16 ~~property assets~~ in accordance with the requirements of the plan of operation under section 8;"

17 (d) Section 6 (D.C. Official Code § 1-307.85) is amended as follows:

18 (1) Subsection (b) is amended to read as follows:

19 "(b) The Advisory Council shall consist of 7 members appointed by the Risk Officer. One
20 member shall represent the District of Columbia Primary Care Association, 2 members shall
21 represent District health centers, 2 members shall have expertise in general property insurance
22 and re-insurance, and 2 members shall have general insurance expertise, whether medical
23 malpractice or general property insurance."

24 (2) Subsection (i) is amended as follows:

25 (A) Paragraph (2) is amended by striking the word "and" at the end.

26 (B) A new paragraph (2A) is added to read as follows:

1 "(2A) Assess the needs and interests of the District with respect to obtaining
2 property insurance through the Agency; and".

3 (e) Section 7(b) (D.C. Official Code § 1-307.86(b)) is amended by striking the phrase
4 "March 2" and inserting the phrase "December 15" in its place.

5 (f) Section 8(b) (D.C. Official Code § 1-307.87(b)) is amended by adding a new
6 paragraph (4A) to read as follows:

7 "(4A) Establish procedures for the offering of property insurance for District real
8 property assets;".

9 (g) Section 11 (D.C. Official Code § 1-307.90) is amended to read as follows:

10 "Sec. 11. Coverage.

11 "(a) The Agency shall offer:

12 "(1) Health centers medical malpractice insurance that is consistent with
13 coverage offered in the market; and

14 "(2) Property insurance for the benefit of the District for District real property
15 assets consistent with coverage offered in the market.

16 "(b) The insurance policies and coverage offered pursuant to this act shall be established
17 by the Risk Officer with the advice of the Advisory Council and subject to the approval of the
18 Commissioner.

19 "(c) Any policy offered by the Agency shall state that the liability of the Agency shall be
20 limited to the funds in the Captive Trust Fund."

21 (h) Section 12(a) (DC Official Code § 1-307.91(a)) is amended by striking the phrase
22 "Medical Liability Captive" and inserting the phrase "Captive" in its place.

23 (i) A new section 16 is added to read as follows:

24 "Sec. 16. Short title.

25 "This act may be cited as the "Captive Insurance Agency Establishment Act of 2008"."

26 **SUBTITLE E. TECHNOLOGY SERVICES SUPPORT**

1 Sec. 1041. Short title.

24 (e) There shall be no limit to the value of goods, services, or currency that may be
25 received from a foreign organization registered or not outside of the District of Columbia or from
26 an individual domiciled outside of the District of Columbia.

19 (8) "Substance abuse" means a pattern of pathological use of a drug or alcohol
20 that causes impairment in social or occupational functioning or produces physiological
21 dependency evidenced by physical tolerance or physical symptoms when the drug or alcohol is
22 not used.

24 (a) There is established as a separate, cabinet-level Department, subordinate to the
25 Mayor, the Department of Behavioral Health.

6 "(16) "Domestic partners" means persons who have registered their relationship
7 with the District pursuant to section 3 of the Health Care Benefits Expansion Act of 1992,
8 effective June 11, 1992 (9-114; D.C. Official Code § 32-702).

9 "(17) "Employee" means an individual having a place of abode or residing or
10 domiciled within the District at the time the tax is required to be withheld in respect to the
11 individual's employment by another, and to every other individual who maintains a place of
12 abode within the District for an aggregate of 183 days or more during the taxable year, whether
13 domiciled in the District or not, including an officer of a corporation, but excluding any elective
14 officer of the government of the United States or any officer or employee in the legislative
15 branch of the government of the United States whose compensation is paid by the Secretary of
16 the Senate or Clerk of the House of Representatives, any officer of the executive branch of the
17 government of the United States whose appointment was made by the President of the United
18 States, subject to confirmation by the Senate of the United States, and whose tenure of office is
19 at the pleasure of the President of the United States, or any Justice of the Supreme Court of the
20 United States, unless the officer, employee, or justice is domiciled within the District of
21 Columbia at any time during the taxable year.

22 "(18) "Employer" means an employer as defined in section 3401(d) of the
23 Internal Revenue Code of 1986.

24 "(19) "Fiduciary" means a guardian, trustee, executor, committee, administrator,
25 receiver, conservator, or any other person acting in any fiduciary capacity for any person.

16 "(29) "International banking facility" or "IBF" shall have the same meaning as

19 "(30) "International banking facility extension of credit" or "IBF loan" shall have

8 of the total amount of income subject to apportionment and an equitable allocation and
9 apportionment of the taxpayer's income.

11 combined reporting and to ensure that the tax liability or net income of any taxpayer whose
12 income derived from or is attributable to sources within the District that is required to be

14 included in the combined report, both during and after the period of inclusion in the combined
15 report, is properly reported, determined, computed, assessed, collected, or adjusted.

16 "(f) The Chief Financial Officer shall adopt regulations as necessary prescribing the form
17 and manner of all returns and reports required under § 47-1805.02a, including the time, place,
18 and extension of such returns and reports.

19 "(g) Any taxpayer election made under § 47-1805.02(5)(C) and the pertinent regulations
20 to file a consolidated return is revoked for tax years beginning after December 31, 2010."

21 (d) Sections 47-1810.04, 47-1810.05, 47-1810.06, 47-1810.07, and 47-1810.08 are

20 Financial Officer may accept those statements with appropriate adjustments to approximate that
21 income.

22 "(4)(A) All dividends paid by one to another of the members of the combined
23 group shall, to the extent those dividends are paid out of the earnings and profits of the unitary
24 business included in the combined report, in the current or an earlier year, be eliminated from the
25 income of the recipient.

3. Facilitate taxpayer convenience and compliance in the filing of tax returns and in other phases of tax administration.
4. Avoid duplicative taxation.

Article II. Definitions.

1. "State" means a state of the United States, the District of Columbia, the Commonwealth of Puerto Rico, or any territory or possession of the United States.
2. "Subdivision" means any governmental unit or special district of a state.
3. "Taxpayer" means any corporation, partnership, firm, association, governmental unit or agency or person acting as a business entity in more than one state.
4. "Income tax" means a tax imposed on or measured by net income including any tax imposed on or measured by an amount arrived at by deducting expenses from gross income, one or more forms of which expenses are not specifically and directly related to particular transactions.
5. "Capital stock tax" means a tax measured in any way by the capital of a corporation considered in its entirety.

19 receipts and disbursements of the Commission shall be subject to the audit and accounting
20 procedures established under its bylaws. All receipts and disbursements of funds handled by the
21 Commission shall be audited yearly by a certified or licensed public accountant and the report of
22 the audit shall be included in and become part of the annual report of the Commission.

16 not within the jurisdiction, he may be required to attend for such purpose at any time and place
17 fixed by the Commission within the state of which he is a resident; provided that such state has
18 adopted this article.

19 4. The Commission may apply through the Mayor of the District of Columbia, to any
20 court in the District of Columbia having power to issue compulsory process for orders in aid of
21 its powers and responsibilities pursuant to this article, if the party or subject matter on account of
22 which the Commission seeks an order is within the jurisdiction of the courts of the District of
23 Columbia. The Commission may apply for such order to the courts of the state or subdivision

5 5. The Commission may decline to perform any audit requested if it finds that its

8 of its experience, has reason to believe that an audit of a particular taxpayer, either at a particular
9 time or on a particular schedule, would be of interest to a number of party states or their

11 participation therein as determined by the Commission.

12 6. Information obtained by an audit pursuant to this article shall be confidential and
13 available only for tax purposes to party states, their subdivisions, or the United States.
14 Availability of information shall be in accordance with the laws of the states or subdivisions on
15 whose account the Commission performs the audit, and only through the appropriate agencies or
16 officers of such states or subdivisions. Nothing in this article shall be construed to require any
17 taxpayer to keep records for any period not otherwise required by law.

18 7. Other arrangements made or authorized pursuant to law for cooperative audit by or on
19 behalf of the party states or any of their subdivisions are not superseded or invalidated by this
20 article.

21 8. In no event shall the Commission make any charge against a taxpayer for an audit.

22 9. As used in this article, "tax", in addition to the meaning ascribed to it in Article II,
23 means any tax or license fee imposed in whole or in part for revenue purposes.

Article IX. Entry into Force and Withdrawal.

2 1. This compact shall enter into force when enacted by any seven states. Thereafter, this

(3) A set of routes and plans to extend the Skyland route to Camp Simms and other extensions in Wards 4, 5, 7, and 8;

(4) An analysis of other ways to fund Circulator extension;

(5) If fares are to be increased, the appropriate effective date for doing so;

(6) Recommendations for improving Circulator operations, including improving route efficiency, passenger satisfaction, and the speed of fare collection; and

(7) A plan for marketing the Circulator expansion and any fare changes.

Sec. 9028. Waste and Recycling Reporting.

(a) On or before December 31, 2013, the Department of Public Works ("DPW") and the Department of General Services shall transmit a report to the Secretary of the Council on recycling by District government agencies. The report shall include:
