SENTENCING GUIDELINES ALERT

This Sentencing Guidelines Alert concerns the ranking of the terrorism offenses contained in Title 22, Chapter 31B of the D.C. Code. The Commission had not previously ranked these offenses. The new rankings, contained in the attached amendments to Appendix C and C-I, apply to pleas or verdicts entered after January 1, 2014. The Commission unanimously approved these rankings on November 19, 2013.
