

How the Commission Defines Compliance with the Guidelines

- A Compliant Sentence is a Sentence That Either
 - Falls Within the Recommended Sentencing Range and Sentencing Options; or
 - Is Outside the Recommended Sentencing Range/Options But is Allowed by the Guidelines Rules
- A Non-Compliant Sentence is a Sentence That Does Not Fall Within the Recommended Sentencing Range/Options and is Not Otherwise Allowed by the Guidelines Rules

Calculating Compliance

- Commission Calculates Compliance with the Guidelines for Initial Felony Sentences Imposed in D.C. Superior Court.

Sentencing Guidelines Overview

• Purpose

• Promote Certainty, Consistency, and Adequacy of Punishment

- Two Primary Factors:
 - Criminal History Score
 - Seriousness of Offense
- Sentencing Guidelines in D.C.
 - Only apply to felony convictions
 - Voluntary Guidelines

The In-the-Box Sentencing Range

- Prior to sentencing, a defendant's in-the-box sentencing range is calculated for each felony offense being sentenced.
- This is done by determining the
 - Defendant's prior criminal history column
 - The severity group for the offense being sentenced
- In-the-Box range is determined by finding the intersection of these two factors on the Guidelines Master Grid or Drug Grid

- Even if the total sentence is within the range, does not mean its compliant
- Sentence type imposed must be an available an option
 - Prison Sentence
 - Short Split Sentence
 - Probation Sentence
- Eligibility determined by the option available in the box
- Prison is always an option
- A Sentence with an Ineligible Sentence Type is Called a "Dispositional Departure"



Sentences Outside the In-the-Box Range

- The Commission classifies sentences outside of the in-the-box range the following ways:
- Outside the Box But Otherwise Compliant
 - The Court Cited a Valid Guidelines Departure Factor
 - Compliant Outside the Box Sentence
- Defendant Sentenced Without a Criminal History Score
- Non-Compliant Sentences
 - The Court Did Not Utilize the Sentence Guidelines When Imposing the Sentence

Compliant Departures

Judge Notes a Valid Guidelines Departure Factor at Sentencing

- The Guidelines Allow a Judge to Cite one of 21 Departure Factors as a Valid Reason for Sentencing a Defendant Outside the In-the-Box Sentencing Range
 - 11 Possible Aggravating Departures Available
 - 10 Possible Mitigating Departures Available
 - Most Common Departure Factor in 2015 Was Mitigating Factor 7, When the Defendant Provided Substantial Assistance to Law Enforcement

Compliant Outside-the-Box Sentences

- An Enhancement Applies (e.g. a crime against a senior citizens)
 - Expands the High End of the Guidelines Range
- Defendant Entered into a Plea Agreement Pursuant to Rule 11(c)(1)(C)
 - All Sentences Following a Rule 11(c)(1)(C) Are Compliant
- Offense Runs Concurrently with a Equal or Greater Sentence
 - Offense Must Be Eligible to Run Concurrent With Another Offense

Non-Compliant Sentences

Guidelines Are 100% Voluntary

- Judges are not required to impose a sentence that is compliant with the Guidelines
- The Commission does not intend for the Guidelines to be applied in every single case sentenced.
- When a judge does not follow the Guidelines, the sentence is classified as non-compliant

Sentences Imposed Without a Compliance Calculation

- Defendant Did Not Receive a Criminal History Score Calculation
- Sentences Following Revocation of Probation
- Sentences Following Remand From the Court of Appeals

Process for Calculating Compliance

- Commission's Guidelines Reporting and Information Data System (GRID system)
 - Automatically calculates compliance based upon Guidelines rules
 - Identifies and separates no CH score, revocation and remand sentences
- All Counts Initially Marked As Non-Compliant by the GRID System are Manually Reviewed by Commission Staff
- Commission Staff Randomly Review Counts Marked as Compliant

Departure Letters

- The Commission Sends Departure Letters to Judges For All Counts That Appear Non-Compliant After Staff Review
- The Letter Contains a Response Form That:
 - Verifies or Corrects the Commissions Data
 - Asks if a Departure Factor Was Used
 - Allows a Judge to Explain Why He or She Did Not Utilize the Guidelines
- Judges Forward Response Forms to the Commission
- Responses are Entered Into the Commission's Database

Compliance Data

- After the Commission Calculates Guidelines Compliance for a Specific Count, the Count Is Incorporated into the Commission's Data
- The Data is Used For
 - The Commissions Annual Report
 - Commission Research
 - Analysis of the Guidelines Performance
 - Respond to Data Requests
