Committment to the Community

The Commission is focused on educating the public on how the Voluntary Sentencing Guidelines (Guidelines) operate. The agency has participated in a variety of in-person and virtual events to provide information and gather feedback from the public. Some of the events include:

- Metropolitan Police Department's (MPD) "National Night Out" and "Beat the Streets" events;
- Advisory Neighborhood Commission (ANC) and MPD Citizen Advisory Council (CAC) community meetings;
- Collaborating with D.C. Public Library, ANC 7F, MPD's PSA 702 Outreach Team, and Court Services and Offender Supervision Agency (CSOSA) for community centered events and presentations; and
- Working with American University and Dunbar High School's Law and Policy Program to educate students on how the adult felony sentencing process works in the District.

The agency hosted its first virtual community event that provided the public with an overview of the adult felony sentencing process. This event also provided attendees with the opportunity to ask the Commission staff questions. The Commission will be hosting more events like this over the next year.

I have been a member of the Commission since July 2023

What led to your decision to pursue law as a career

I had the desire to become a lawyer since the age of 7. I spent a lot of my youth watching my family members participate in local politics and serve in my community. Their service and commitment to helping others inspired me to pursue this career path.

What is your favorite part about being on the Commission?

I am passionate about pursing policies and programs that promote access to justice. I get an opportunity, through my role on the Commission, to make recommendations that impact access to justice for those who are impacted by criminal justice. When fairness is at the forefront of decision making everyone benefits

If you could wave a magic wand, what change (if any) would you like to see in the criminal justice community?

I would increase the number of restorative justice programs that address the root causes of criminal behavior and recidivism, particularly among the youth. I would also recreate communities, like the ones that I grew up in, where neighbors were more like families rather than strangers. Most youth violence is centered in communities where youth live. I would create more positive and sustainable changes where youth, who are "at-risk", live.
