




# 2023 Annual Report Recap

The agency published its 2023 Annual Report for community members and practitioners. Below are some 2023 DC adult felony sentencing key facts from the report:

- A total of 1,007 individuals were sentenced in D.C. Superior Court.
- 62% of felony cases received prison sentences.
- 19% of felony cases received a probation sentences.
- In D.C. in 2023, 87% of all defendants sentenced to prison were under the age of 41.
- Collectively, Carrying a Pistol without a License (CPWL) and Unlawful Possession of a Firearm Prior Conviction (UPF-PF) represent 76% of weapon offenses sentenced.
- Combined, Assault with a Dangerous Weapon (ADW) and Robbery represent 67% of violent offenses sentenced.

This year, the Commission's membership has grown. Under the Secure DC Ominibus Amendment Act of 2024, membership increased from 17 to 20 members.

Three new membership positions were added, including:

- A Second Mayoral Resident Appointment (voting)
- A DC Council Resident Appointment for a Crime Victim/Victims' Rights Advocate (voting)
- Deputy Mayor of Public Safety Appointment (non-voting)


As part of this change, the Metropolitan Police Department's membership on the Commission was upgraded to a voting position.
